## DEED OF VARIATION

The parties to this Deed are:

(1) The Secretary of State for Education ("the Secretary of State"),

- and -

(2) Fierté Multi-Academy Trust, a charitable company incorporated in England and Wales with registered number 07606026 ("the Academy Trust").

together referred to as the "Parties"

### INTRODUCTION

- A. The Parties entered into a Master Funding Agreement dated 29 September 2016 ("the Master Funding Agreement") relating to the establishment, maintenance and funding of Academies.
- B. The Parties entered into a Supplemental Funding Agreement in relation to Anker Moor Primary School dated 29 September 2016, a Supplemental Funding Agreement in relation to Violet Way Academy dated 11 October 2016 and a Supplemental Funding Agreement in relation to Glascote Academy dated 11 October 2016 ("the Supplemental Funding Agreements").
- C. The Academy Trust has changed its name from Violet Way Trust to Fierté Multi-Academy Trust.
- D. The Parties now wish to vary and amend the terms of the Master Funding Agreement and the Supplemental Funding Agreements and wish to record their agreement as to such variations/amendments by this Deed.

### LEGAL AGREEMENT

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Master Funding Agreement, or the Supplemental Funding Agreements bear the meaning given to it in the Master Funding Agreement or the Supplemental Funding Agreements as the case may be.
- 2. The Parties agree that with effect from the date of this Deed the Master Funding Agreement and the Supplemental Funding Agreements shall be amended in accordance with Schedule 1 to this Deed.
- 3. As varied by this Deed, the Master Funding Agreement and the Supplemental Funding Agreements shall remain in full force and effect.
