- (1) The Secretary of State for Education (“Secretary of State”); and
 - (2) Advance Trust, a charitable company incorporated in England and Wales with registered number 08414933 (“Company”)
- together referred to as the “Parties”.

INTRODUCTION:

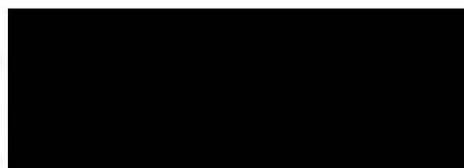
- (A) The Parties entered into a supplemental funding agreement dated 25 March 2013 (“Funding Agreement”) relating to the establishment, maintenance and funding of a school known as the Vale of Evesham School.
- (B) The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

IT IS AGREED as follows:

1. The Secretary of State and the Company agree that with effect from the date of this Deed the Funding Agreement shall be amended and restated in the form set out at Schedule 1 to this Deed.
2. As varied by this Deed, the Funding Agreement shall remain in full force and effect.
3. This Agreement shall be governed by and interpreted in accordance with English law.

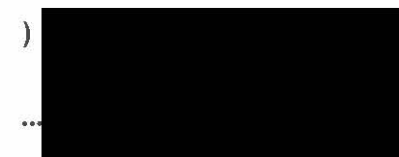

SCHEDULE 1 - Restated form of Funding Agreement

Clause 4.1 of the Funding Agreement is deleted and replaced by:

The planned number of places at the Special Academy is 172 in the age range 2 to 19, including facilities for 15 full time equivalent boarding pupils, a sixth form of 29 places and a nursery unit of 10 places. The number of funded places and the 2 to 19 age range is/are not determinative of GAG. GAG for each Academy Funding Year will be determined by the Secretary of State in accordance with clauses 54C and 54D of the Master Agreement.
