## DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 2<sup>1</sup> day of AUGUST 2017

### BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) Central RSA Academies Trust (formerly known as Redditch RSA Academies Trust), (the "**Company**") a charitable company incorporated in England and Wales with registered number 08166526, together, the "**Parties**".

### INTRODUCTION

- A. The Parties entered into a Master Funding Agreement dated 30 August 2012 (as varied by a Deed of Variation dated 29 February 2016), a Supplemental Funding Agreement in relation to Arrow Vale RSA Academy dated 30 August 2012 (as varied by a Deed of Variation dated 29 February 2016), a Supplemental Funding Agreement in relation to Ipsley CE RSA Academy dated 20 December 2012 (as varied by a Deed of Variation dated 29 February 2016), a Supplemental Funding Agreement in relation to Church Hill Middle School RSA Academy dated 29 February 2016 and a Supplemental Funding Agreement in relation to Abbeywood First School RSA Academy dated 29 February 2016 (together the "**Funding Agreements**") relating to the establishment, maintenance and funding of Academies in accordance with the Funding Agreements.
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreements in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Funding Agreements.

### 1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreements.

### 2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Funding Agreements shall be amended as follows:

All references in the Funding Agreements to Redditch RSA Academies Trust shall be deleted and replaced with references to Central RSA Academies Trust.

- 2.2 Except as varied by this Deed, the Funding Agreements shall remain in full force and effect.

**3. Governing law and jurisdiction**

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.
- 3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. Counterparts**

- 4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
